1. Administration and Finance

a. 2025 General Obligation Limited Tax Park Bonds (Rollover bonds) Presentation

Staff will present the 2025 General Obligation Rollover Bonds process and preliminary financing model. A BINA Public Hearing was conducted on 1/9/24 for \$4,600,000 which included the total bond issuance for two one-year rollover bonds in 2024 and 2025, therefore, a BINA Public Hearing is not required in 2025.

b. 2025 Rates & Fees Schedule

Effective January 1, 2025, leased and rented tangible personal property in the ordinary course of business will be subject to sales tax. This was approved by Illinois Department of Revenue in December and therefore was not taken into consideration during the 2025 budget process. Staff present minor revisions to the FY2025 Rates & Fees schedule for golf and mini golf rentals. Board action is requested.

c. Renewal of Membership in the Illinois Association of Park Districts

Board approval is requested to renew the St. Charles Park District's membership in the Illinois Association of Park Districts (IAPD) for a fee of \$7,539.29. This is a budgeted expense. Board action is requested.
